Order

Sri DVN Santosh, Rajendranagar, Ranga Reddy District has filed 2nd appeal dated: 20-03-2020 which was received by this Commission on 28-03-2020 for not getting the information sought by him from the PIO / O/o the Directorate of School Education, B-block-2, Beside, Telephone Bhavan Road, Saifabad, Hyderabad and 1st Appellate Authority / O/o the Directorate of School Education, B-block-2, Beside, Telephone Bhavan Road, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 11-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

While enclosing the above Indian Postal Order in the name of the Accounts Officer / Pay and Accounts Officer of your office, as required under the RTI Act, I request you to furnish me with a copy of the following information.

2. Note orders and memos and draft orders of total sanctioned budget allotted in detail abstract should be supply of 65th SGFTS State level BADMINTON Under 17 Years Boys and Girls Tournament Cum Selections held at TNGO's Bhavana and District Club Mahabubnagar District from 02-11-2019 and 04-11-2019. And School National Camp budget.

Complaint

DISCIPLINARY AUTHORITY UNDER RULE 11 OF C.C.A & CONDUCT RULES AS APPLICABLE TO THE STATE OF TELANGANA

- > Will you allow your family members to go to same wash room at tournament place who are teens? If so will they not get infections and how worst were toilets for girls no change in situations and circumstances of our life in sports even after 20 years. Will you take your family members with General ticket for Tour? How do you expect they perform for long journeys.
- > Unfit and un-size kits supplied to players for School Nationals. We gave fee to outsiders.

We are EX-International Volleyball Player in 1997 we played under 19 years SGFTS at REWA, MP. 20 years back the same situation is still continuing now no change. This the fate of Sports in our State of Telangana only corruption. Next Appellate Authority is Chief Secretary Telangana Rule 34 of CCA Conduct Rules 1964 and General 3 and 3A. And detail inquiry and investigation report may call for by entrusting trust worthy and honesty officers and committee to bring all corruption into day light along with action as CVC Guiltiness No.000/VGL/18 Government of India dated 23-05-2000 and Prevention of Corruption Act, 1988 and ACB guidelines and manuals

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 21-02-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M. Since the appellant is seeking the same information in both the cases common order issued.

The case is called on 26-08-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri G. Parmesham, Assistant Director, O/o the Director of School Education, Saifabad, Hyderabad is present and filed his affidavit stating that vide letter No: 12/RTI/2019 dated: 18-01-2020 the application was forwarded to the PIO / O/o the District Educational Officer, Mahabubnagar District with a request to furnish the information to the appellant and on receipt of the Commission notice dated: 29-07-2021 a reminder notice was once again sent on 21-08-2021. The PIO filed copy of the letters communicated before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed a complaint dated: 11-01-2020 seeking the Note orders, Memos and draft orders of total sanctioned budget allotted in detail abstract of 65th SGFTS State level Badminton under 17 year boys & girls tournament cum selection held at TNGO's Bhavan and District Club Mahabubnagar District from 02-11-2019 and 04-11-2019 and School National Camp budget. The Commission is not satisfied with the reply of the PIO. The PIO ought to have furnished the available information to the appellant.

The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the complete information duly attesting the same to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeals are closed.
