Order

LT. Col. Brij Nath Singh Tyagi, Secunderabad has filed 2nd appeal dated: 25-03-2019 which was received by this Commission on 29-03-2019 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 10-12-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Please refer my complaint dated 04.11.2016 against the fraud played upon the Court to obtain "Dismissal on Default Order" dated 28.09.2016, in CRP No. 1642 of 2016.
2. Since the inquiry in the matter is completed, it is requested that the following information's may be supplied to the applicant:-
 - (a) Findings of the inquiry held in my complaint dated 04.11.2016 that fraud was played upon the court to get CRP No 1642 / 16 "Dismissed on Default on 28.09.2016,
 - (b) Copy of directions / recommendations relating to recall the "Dismissal on Default Order dated 28.09.2016" in CRP-1642 of 2016.

The PIO vide ROC No.843/PIO/JUDL/2018 dated. 20-12-2018 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 20-01-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The appellant is absent. Sri M. Sudharshan, Advocate on record for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and filed his affidavit stating that a reply was given to the appellant vide letter ROC. No: 843/PIO/JUDL/2018 dated: 20-12-2018 informing that the information was already furnished to the appellant vide Order ROC No: 243/PIO/JUDL/2017 dated: 29-04-2017.

Heard the PIO and perused the material papers available on record and concurrent finding of the order of the PIO.

No orders are necessary in this appeal, hence closed.
