Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2nd appeal dated: 07-01-2020 which was received by this Commission on 13-01-2020 for not getting the information sought by him from the PIO / O/o the District Revenue Officer, Komarambheem Asifabad District and 1st Appellate Authority / O/o the Joint Collector, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 04-11-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. 02.2019 నిర్దేశముల ప్రకారం పరిష్కరించవలసినవిగా ముఖ్య కార్యాలయాలకు, Divisional, Mandal అధికారుల కార్యాలయాలకు ఆకస్మిక తనివీలు, వాటి ఆధారంగా మీరు చేపట్టిన చర్యల వివరాలను ఇవ్వగలరు.
2. జిల్లాలో ఆహార కల్పి/సంరక్షణ కల్పి/పత్తాళియం కల్పి నివారణ కొరకు రోజువారీ చేపట్టిన చర్యల వివరాలను 2017-18 నుండి నేటి వరకు ఇవ్వగలరు.
3. PDS బియ్యం ఒక పర్యాయం కంటే ఎక్కువ సార్లు అమ్ముతూ పట్టుబడ్డ వారిపై మీరు చేపట్టిన చర్యల వివరాలను 2017-18 నుండి నేటి వరకు ఇవ్వగలరు.
4. కేంద్ర ప్రభుత్వము జారీచేసిన సర్క్యులర్ నెం. 1/2017, తేది: 20/05/2017 ప్రకారం District Purchasing కమిటీ అధ్యక్షులలో కాకుండా సేరుగా కొనుగోలు చేసిన వారిపై తీసుకున్న చర్యల ప్రతులు ఈ బిల్లులను ఆమోదించడానికి పెట్టిన సంబంధిత అధికారులపై తీసుకున్న చర్యల ప్రతులను 2017-18 నుండి నేటి వరకు ఇవ్వగలరు.
5. Joint Collector, District Revenue Officer, District Civil Supply Officers', Revenue Division Officer యొక్క Vehicle యొక్క Log Book ప్రతులను 2017-18 నుండి నేటి వరకు ఇవ్వగలరు.
6. Joint Collector, District Revenue Officer, District Civil Supply Officer's, Revenue Division Officer వారి యొక్క Vehicle "ప్రైవేటు వెహికల్ ఆన్ గవర్నమెంట్ డ్యూటీ" ఉన్నచో ప్రభుత్వం ద్వారా జారీ చేసిన మరియు మీ కార్యాలయ లేఖ నెం.A2/522/2017, dt. 22-02-2019 నిబంధనల ప్రకారం Check List లు ఇవ్వగలరు.

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 09-12-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The appellant is present and stated that the PIO has furnished the information. The APIO / Sri Rafatulla Hussain, Administrative Officer is present and filed the affidavit of the PIO / Sri K. Suresh, District Revenue Officer, O/o the District Collector, Komaram Bheem Asifabad District stating that vide letter No: A2/1097/2019 dated: 08-11-2019 and 07-02-2020 the application was transferred to the PIO / O/o the DCSO, Komaram Bheem Asifabad District with a request to furnish the information. The PIO / DCSO, Komaram Bheem Asifabad District vide letter No: A/194/RTI/2019 dated: 31-03-2021 has furnished the information to the appellant. The APIO filed a copy of the information furnished along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present & the then PIO / O/o the District Civil Supply Officer, Komaram Bheem Asifabad District for not furnishing the information to the appellant within the stipulated period even after transferring the application twice u/s 6(3) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
