Order

Sri K. Jitender, Ranga Reddy District has filed 2nd appeal dated: 03-06-2020 which was received by this Commission on 04-06-2020 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Circle No. 11, GHMC, Rajender Nagar, Hyderabad and 1st Appellate Authority / O/o the Zonal Commissioner, Charminar Zone, GHMC, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 31-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 27-02-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The representative (Son) of the appellant informed over phone that the appellant Sri K. Jitender was expired on 17-05-2021. The PIO / Dr. P. Padma, Assistant Medical Officer of Health, O/o the Deputy Commissioner, RJNR Circle - 11, CRZ, GHMC, Hyderabad is present and submitted that the information was furnished to the appellant vide letter No: F1/AMOH11/2020 dated: 04-02-2020 and filed a copy of the same before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 31-01-2020 seeking certain information and the PIO has furnished the information to the appellant.

In view of the above, the appeal is closed.
