Order

Sri Mohan Rangu, Warangal Rural District has filed 2nd appeal dated: 01-06-2020 which was received by this Commission on 08-06-2020 for not getting the information sought by him from the PIO / O/o the TREI-Recruitment Board, Chacha Nehru Park, Masabtank, Hyderabad and 1st Appellate Authority / O/o the TREI-Recruitment Board, Chacha Nehru Park, Masabtank, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-09-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Masabtank, Hyderabad - 500001.

Subject: Give me the details of social post (TREIRIS - 2018) selected candidates of the zone V who belong to OC- General in a sequence order with serial number and BC General (ii) Mr. RANGU MOHAN Hall ticket No. 102150 - Scale Social group BC - B-4 - I made of me who is bearing HTN 410506 selected to MJPBCWREIS, his rank (B Scale) 1123. This is not accurate and transparent. How it is possible. Give me a reply by filling the below format.

From your information of General posts: 11 BC - B General posts. 0

2. Is anybody relinquished from social - post. Mention the details.

And more few points.

The PIO vide Lr.Rc. No. 12/RTI-ACT/TREI-RB/2018 dated: 18-09-2019 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 16-12-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 05-02-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri U. Lava Kumar, Superintendent and Sri Linga Reddy, Assistant Secretary, (OSD-Legal), O/o the TREI-Recruitment Board, Hyderabad are present and filed their affidavits stating that a reply was given to the appellant vide letter Rc. No: 12/RTI/TREI RB/2018 dated: 18-09-2019 and vide letter dated: 20-01-2020. The PIO filed the copy of the information furnished to the appellant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 03-09-2019 seeking information on 3 points which is in questionnaire form and tabular format. The PIO submitted that the information for point No: 3 & 4 is brought to the Commission and is ready to be furnished the appellant. The PIO furnished the information before the Commission to the appellant.

The Commission directs the PIO to furnish the information for point No: 1 & 2 to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
