## Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2<sup>nd</sup> appeal dated: 28-05-2020 which was received by this Commission on 10-06-2020 for not getting the information sought by him from the PIO / O/o the Sub-Registration Office, Mancherial District and 1<sup>st</sup> Appellate Authority / O/o the District Registrar Office, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 30-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ఆలంగాణ రాష్ట్రం ఏర్పడినప్పటి నుండి నెట్ బంకు మీ కార్కాలయ పరు మీదగల bank account number & bank Transaction statements ను accounts వారీగా along with CASH BOOK, Acquaintance voucher వారీగా ఇవ్వాలను మీకు AMOUNT SANCTION కొంకు వచ్చిన ఆర్డర్స్ అండ్ బుక్ కు సంబంధించిన మార్గదర్శకాలు ఇవ్వాలను
  - మీ కార్కాలయం పై Accreditation పొందిన బడ్జెట్ లలో వచ్చిన Reverse Trans పై మీకు రోజుకునూ ఐదేల రూపాయి వాటి ప్రాసెసింగ్ తోపాటు తెలియపరచాలను.
  - RTI Act లోని సెక్షన్ 4 ప్రకారం మరియు DOPT జారీ చేసిన మార్గదర్శకాల SUWOTO DISCLOSURES ను మీకు నెట్ బుక్ లకు తెలియపరచినారే వాటి రుజువులను electronic మరియు manual mode లో ప్రతులు అందకల ప్రకారం ఇవ్వాలను.
  - RTI Act కి సంబంధించిన REGISTER 1 & 2 ను ఇవ్వాలను
  - మీ ఆఫీసుకు వచ్చిన 6 (1) APPLICATIONS & 19 (1) APPEAL ORDERS లను 2 (1) ప్రకారం ఇవ్వాలను
  - మీ office కు వచ్చిన మరియు పంపిన E mails ప్రతులు, వచ్చిన మరియు ఇచ్చిన MEMOS, ప్రతులు, circulars, orders, AUDIT PAPERS Disiplinary proceedings లను 2017 చూడే నెట్ బంకు ఇవ్వాలను
  - మీ కార్కాలయానికి 1-11-2017 నుండి నెట్ బంకు వచ్చిన గానాదాస్ ప్రతులను వాటి పై మీకు రోజుకునూ ఐదేల రూపాయి with rule position తో పాటు పూర్తి file ను ఇవ్వాలను

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 27-02-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri E.V. Murali Krishna, Sub-Registrar, I/c, Mancherial District is present and filed his affidavit stating that vide letter No: 98/2020 dated: 29-02-2020 the appellant was requested to pay Rs. 4552/- to furnish the information sought and filed a copy of the letter along with the postal evidence before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 30-01-2020 seeking information on 7 points. The PIO submitted that since the appellant did not pay the requisite fee the information was not furnished.

The Commission directs the PIO to arrange for verification of records on a mutually fixed date and time by giving prior intimation to the appellant and furnish specific information as sought through his 6(1) application dated: 30-01-2020 to the appellant and to report compliance to the Commission.

With the above direction, the appeal is closed.
