## **Order**

Sri. Mohd Ashraf, Sirpur-Kagaznagar, Kumarambheem Asifabad District has filed 2<sup>nd</sup> appeal dated: 28-05-2020 which was received by this Commission on 10-06-2020 for not getting the information sought by him from the PIO / O/o the Sub-Registrar, Komarambheem Asifabad District and 1<sup>st</sup> Appellate Authority / O/o the District Registrar, Komaram Bheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2. Registration and Stamp Department Memo NO. G3/3247/2018 DATED:1-5-2019 ప్రకారం మీరు తీసుకున్న చర్యల ప్రతులను DISTRIBUTION REGISTER, PERSONAL REGISTER మరియు PERIODICAL REGISTER, & note ఫైల్ తో పాటు ఇవ్వగలరు.
3. 1 మే 2018 నుండి నేటి వరకు మీ ఆఫీస్ ద్వారా రిజిస్ట్రేషన్ అయిన వాటి వివరాలు మండలము మరియు గ్రామపంచాయతీవారిగా ఇవ్వగలరు
4. 1 మే 2018 నుండి నేటి వరకు మీ ఆఫీస్ ద్వారా రిజిస్ట్రేషన్ అయిన వాటిలో Registration and Stamp Department Memo NO. G3/3247/2018 DATED:1-5-2019 ప్రకారం అన్ని CONVERSATION CERTIFICATE OF AGRICULTURAL LAND INTO NON- AGRICULTURAL LAND బదిలీ జరిగినది దో వాటి వివరాలు మండలము మరియు గ్రామపంచాయతీవారిగా ఇవ్వగలరు.
5. మీ కార్యాలయం యొక్క 4(1)B ని interval వారిగా 2018 DOPT జారీచేసిన నూతన మార్గదర్శకాల ప్రకారం నుండి నేటి వరకు ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 29-02-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 15-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 15-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished any information till the date of hearing. Sri. Vivek, Junior Assistant, O/o the Sub-Registrar, Asifabad responded and filed affidavit of the PIO / Sri. K. Vijayakanth Rao, Sub-Registrar, Asifabad, Komaram Bheem Asifabad District stating that the information was furnished to the appellant vide letter No: SRO/ASF/45/2020 dated: 27-02-2020, but failed to submit the postal evidence of furnishing the information to the appellant before the Commission.

Heard both the parties and perused the material paper available on record and observed that the appellant through his 6(1) application dated: 22-01-2020 seeking information on 5 points. Upon not filing any documentary evidence of furnishing the information, the Commission cannot accept the submission of the PIO.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Sri. K. Vijayakanth Rao, Sub-Registrar, Asifabad, Komaram Bheem Asifabad District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the complete information once again to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
