Order

Smt. Yasmmen Sultana, Hyderabad has filed a Complaint dated 16-01-2020 which was received by this Commission on 16-01-2020 for not getting the information sought by her from the PIO / O/o the Telangana Residential Institutions Society, 4th Gagan Vihar, Nampally, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 11-12-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application annexed.

I most humbly request to give service book of the above mentioned as per the right to information act.
So kindly give the service book as soon as possible for the address given below or I personally want to take.

Stating that the PIO has not furnished the required information even after 30 days of filing her application, she preferred this Complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Sri R. Balaiah, Assistant Secretary (FAC), O/o the Telangana Residential Institutions Society, Nampally, Hyderabad is present and filed his affidavit stating that a reply was given to the complainant vide letter RC. No: 2437/A1-2/2019 dated: 09-01-2020 and filed copies of the letters along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 11-12-2019 seeking her Service Register Book and the PIO vide letter dated: 09-01-2020 advised the complainant to approach the Principal, TMR School, Ibrahimpatnam which was her last place of work. The complainant stated that she has approached the school and they have informed that the Service Register Book is not found. The PIO further submitted that duplicate Service Register Book has been prepared and once the required documents are submitted by the complainant the same will be furnished to her.

In view of the above, the Commission advises the complainant to submit the relevant documents as sought by the PIO and also directs the PIO to furnish the Service Register Book to the complainant and to report compliance to the Commission.

With the above direction, the complaint is closed.
