## Order

Sri P. Ramakrishna, Bodhan has filed a Complaint dated 16-06-2020 which was received by this Commission on 20-06-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Bodhan Municipal Corporation, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 03-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 23-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 23-07-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has furnished incomplete information. The PIO / Sri. Narayandas, Manager, Bodhan Municipal Corporation, Nizamabad District responded and stated that the information was furnished to the complainant vide letter No: 94/RTI/2019 dated: 25-07-2020 and filed a copy of the information furnished to the complainant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 03-01-2020 seeking certain information. The complainant submitted that the PIO has not furnished the complete information.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to arrange for verification of records on a mutually convenient date and time by issuing prior intimation to the complainant to enable him to obtain the required information within Two (2) Weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
