Order

Sri K. Anjaiah, Sangareddy District has filed a Complaint dated 29-06-2020 which was received by this Commission on 30-06-2020 for not getting the information sought by him from the PIO / O/o the Mandal Parishad Development Officer, Kangti Mandal, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 02-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The complainant is absent. The PIO / Sri G. B. Venkata Narsimha Reddy, Superintendent, O/o the Mandal Praja Parishad Development Office, Kangti Mandal, Sanga Reddy District is present and submitted his affidavit stating that vide letter No: A2/49/2020 dated: 20-05-2020 the complainant was requested to pay Rs. 56/- (Rs. 2*3pages + Rs.50/- postal charges) and vide letter No: A2/49/2020 dated: 11-06-2020 the PIO furnished the information to the complainant. The PIO filed the copy of the letters before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 02-05-2020 seeking information on certain point and the PIO has submitted that the information is furnished. The complainant through his complaint dated: 27-07-2020 & 14-08-2020 stated that the PIO has furnished incorrect and misleading information.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Sri G. B. Venkata Narsimha Reddy, Superintendent, O/o the Mandal Praja Parishad Development Office, Kangti Mandal, Sanga Reddy District for furnishing incorrect & misleading information to the complainant. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish complete information to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
