Order

Sri A. Bal Reddy, Ranga Reddy District has filed a Complaint dated: 31-12-2018 which was received by this Commission on 02-01-2019 for not getting the information sought by him from the PIO / O/o the Superintendent, Junior Civil Judge Court, Pargi.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 16-08-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

And more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 10.30 A.M.

The case is called on 17-09-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Sri. K. Ravinder Reddy, Superintendent, O/o the Junior Civil Judge Court, Pargi, Vikarabad District is present and stated that the complainant is seeking information which belongs to several other PIOs and the information for point No: 6, 7 & 8 were furnished on 14-09-2018. The PIO failed to submit the documentary evidence of furnishing the information to the complainant before the Commission.

Heard both the parties and perused the material papers available on record. The PIO stated that the information relating to point No: 1 pertains to Chevella Civil Court, Point No: 2 pertains to Vigilance & Point No: 3, 4 & 5 are hypothetical.

The Commission directs the PIO to furnish the available information relating to their office only duly attesting the same to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
