## **Order**

Smt. K. Bharathi, Rangareddy District has filed 2<sup>nd</sup> appeal dated: 17-01-2020 which was received by this Commission on 17-01-2020 for not getting the information sought by her from the PIO / O/o the Panchayat Secretary, Gram Panchayat of Pandilla Village, Husnabad Mandal, Siddipet District and 1<sup>st</sup> Appellate Authority / O/o the Mandal Praja Parishad, Husnabad Mandal, Siddipet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 09-08-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

I Bharathi .K w/o K . Surender R/o 2-2-123, Nagole Village , Uppal Mandal ,R.F. Dist -500063 ,I would like to consideration and information under Right to Information Act

I submit that Application for regarding property details to issue me certified copy of tax receipts for 20 yrs bearing H.No:3-82 having extent: 4 guntas situated at pandilla village Husnabad Mandal Siddipet Dist authoritative letter under Right to information Act

I submit that the please kind officer regarding property details to issued me certified copy of tax receipts as possible upto 20 years 1985 to till this year bearing i.e H.No:3-82 having extent: 4 guntas situated at pandilla village Husnabad Mandal Siddipet along with authoritative letter under Right to Information through Right to Information Act section6(3)

I am here with enclosing challan bearing No. 859973400 for Rs /- Dated

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 02-12-2019 before the 1<sup>st</sup> Appellate Authority requesting her to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, she preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 12:00 P.M.

The case is called on 17-09-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri K. Srinivas, Panchayat Secretary, Pandilla Village, Husnabad Mandal, Siddipet District is present and stated that the complete information is brought to the Commission and is ready to be furnished to the appellant.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 09-08-2019 seeking certain information and the present PIO has furnished the information before the Commission.

The Commission took a serious view and directs to issue **Show Cause Notice** to the then PIO / Sri Thirupathi, Panchayat Secretary, Pandilla Village, Husnabad Mandal, Siddipet District presently working was Panchayat Secretary, Mulugu Mandal, Mulugu District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
