**Order**

Sri. S. Anjalaiah, Wanaparthy District has filed 2<sup>nd</sup> appeal dated: Nil which was received by this Commission on 17-01-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Kothakota Mandal, Wanaparthy District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Wanaparthy Division, Wanaparthy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-10-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 14-11-2019 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is absent. The PIO / Sri A. Radhya Naik, Deputy Tahsildar, Kothkota Mandal, Wanaparthy District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: B/2722/2019 dated: 22-11-2019 and on receipt of the Commission notice dated: 16-07-2021 the information was once again given to the appellant by hand and filed the copies of the information furnished along with the acknowledgement of the appellant before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 26-10-2019 seeking information on 5 points and the PIO has furnished the information.

Since the information is furnished, the appeal is closed.
