Order

Sri K. Jitender, Ranga Reddy District has filed 2nd appeal dated: 16-07-2020 which was received by this Commission on 17-07-2020 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Rajendranagar, Circle-11, GHMC, Rangareddy District and 1st Appellate Authority / O/o the Zonal Commissioner, GHMC, Charminar Zone, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 08-06-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 16-09-2021 at 10.30 A.M.

The case is called on 16-09-2021. The appellant is absent. Sri G. Rakesh, Section Officer is present on behalf of the PIO / Smt. Inukonda Rani, Assistant City Planner, O/o the Deputy Commissioner, Rajender Nagar, Circle – 11, GHMC, Ranga Reddy District and filed her affidavit stating that the information was furnished to the appellant vide letter No: 159/RTI/TPS/RJNR/C11 /CRZ/GHMC/2020-21 dated: 14-09-2021 and filed a copy of the information furnished to the appellant before the Commission.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
