## Order

Sri M. Rama Krishna, Nizamabad District has filed a Complaint dated: 11-07-2020 which was received by this Commission on 18-07-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Navipet Mandal, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

అంగాపూర్ Lingapur గ్రామాలకు సంబంధించిన రేషన్ కార్డుల  
Ration card ల వివరాలు D.V.D లు పొందుపరిచి డి.వి.డి లను  
డ్యూప్లికేట్ రింజు ఇవ్వాలని. డి.వి.డి లను ఆన్లైన్ పుస్తకం నేను  
చెల్లవలసి.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The complainant is absent. The PIO / Sri B. Rajashekhar, Deputy Tahsildar, Navipet Mandal, Nizamabad District is present and stated that the information was furnished to the complainant vide letter No: A/231/2020 dated: 03-07-2020 and filed the copy of the information furnished to the complainant before the Commission.

Heard the PIO and perused the material paper available on record and observed that the complainant filed 6(1) application dated: 12-05-2020 seeking information on 2 points and the PIO has furnished the information to the appellant.

Since the information is furnished, the complaint is closed.
