## Order

Sri. Chiranji Suman, Sangareddy District has filed 2<sup>nd</sup> appeal dated: 27-07-2020 which was received by this Commission on 28-07-2020 for not getting the information sought by him from the PIO / the Gram Panchayat Secretary, Munipally Village & Mandal, Sangareddy District and 1<sup>st</sup> Appellate Authority / O/o the Mandal Praja Development Officer, Munipally Village & Mandal, Sangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 06-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- (3) 2019 నుండి ముఖ్యమంత్రి ప్రభుత్వం కింద 'వారి-7' కు సంబంధించిన సమాచారం తెలియజేయమని ప్రార్థన.
- (4) 2019 నుండి ముఖ్యమంత్రి ప్రభుత్వం కింద 'వారి-7' కు సంబంధించిన సమాచారం తెలియజేయమని ప్రార్థన.
- (5) 2019 నుండి 5/5/2020 వరకు ముఖ్యమంత్రి ప్రభుత్వం కింద 'వారి-7' కు సంబంధించిన సమాచారం తెలియజేయమని ప్రార్థన.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 23-06-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The appellant is absent. The PIO / Smt P. Anjani Devi, Mandal Parishad Officer and Sri Ramesh Chandra Kulkarni, Mandal Parishad Development Officer, Municipally Mandal, Sanga Reddy District are present and filed their affidavits stating the that part information was furnished to the appellant vide letter dated: 10-07-2020 and complete information was furnished to the appellant vide letter No: GP/2/RTI/2020 dated: 30-07-2020. The PIO filed the copy of the information furnished to the appellant along with the postal receipt before the Commission.

Heard the PIOs and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 06-05-2020 seeking information on 5 points and the PIO / Panchayat Secretary, O/o the Gram Panchayat, Municipally vide letter dated: 25-05-2020 requested the appellant to pay Rs. 3100/- (1500 Pages @ Rs. 2/- per page and Rs.100/- for postal charges) to furnish the required information. The appellant vide DD No: 020438 dated: 03-06-2020 has paid the amount and the PIO through letter dated: 01-07-2020 has furnished the information.

The appellant through his 2<sup>nd</sup> appeal dated: 28-07-2020 stated that the PIO furnished 68 pages instead of 1500 pages for which the PIO submitted that the amount of Rs. 3100/- was refunded to the appellant on 06-07-2020 and the information was furnished to the appellant for free of cost.

The Commission warns the PIOs to be cautious and not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
