## **Order**

Sri Kalali Veera Goud, Sangareddy District has filed a Complaint dated: 27-07-2020 which was received by this Commission on 28-07-2020 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 29-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Development activities taken under 10 days action plan (Palle Pragathi) programme
2. Details of ST Junior Panchayat Secretaries working in the District and their name along with working place
3. Details of SC Junior Panchayat Secretaries working in the District and their name along with working place
4. Details of OC Junior Panchayat Secretaries working in the District and their name along with working place
5. Details of BC-A,B,C,D Junior Panchayat Secretaries working in the District and their name along with working place
6. Details of PHC Junior Panchayat Secretaries working in the District and their name along with working place

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 27-08-2021 at 10.30 A.M.

The case is called on 27-08-2021. The complainant is absent. The PIO / Sri A. Durga Prasad, Administrative Officer, O/o the District Panchayat Officer, Sanga Reddy District is present and stated that the complainant is seeking vast information.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the available information to the complainant (keeping in view of Section 8, 9, 10 & 11 of RTI Act 2005) within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
