Order

Sri Kalali Veera Goud, Sangareddy District has filed a Complaint dated: 27-07-2020 which was received by this Commission on 28-07-2020 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 22-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Action taken report my representation dated: 07.12.2019
2. Reason for delay on disposing my petition by the DPO/MPO/JPS
3. Citizen Chart of District Panchayat Office, Sangareddy
4. Citizen Chart of Divisional Panchayat Office, Sangareddy
5. Citizen Chart of Mandal Panchayat Offices & MPDO offices

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 27-08-2021 at 10.30 A.M.

The case is called on 27-08-2021. The complainant is absent. The PIO / Sri A. Durga Prasad, Administrative Officer, O/o the District Panchayat Officer, Sanga Reddy District is present and submitted that the complaint dated: 07-12-2019 is not received and the information sought relates to several other Public Authorities, hence the same could not be furnished.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give point wise reply only relating to the O/o the District Panchayat Officer, Sanga Reddy District to the complainant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission. The complainant is advised to file separate 6(1) application before the concerned Public Authorities for obtaining the information.

With the above direction, the complaint is closed.
