Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2nd appeal dated: 17-07-2020 which was received by this Commission on 28-07-2020 for not getting the information sought by him from the PIO / O/o the Principal Secretary to School Education Department, Telangana Secretariat, Hyderabad and 1st Appellate Authority / O/o the Principal Secretary to School Education Department, Telangana Secretariat, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 10-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. నేను మీ కార్యాలయము లో 26-12-2019 రోజున SPOUSE CATEGORY POINTS MISUSED పై సమర్పించిన ప్రాతినిధ్యం పై మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Periodical Register, Distribution Register, Note File with Rule Position తో పాటు ఇవ్వగలరు.
2. నేను మీ కార్యాలయము లో 18-11-2019 రోజున C & DSC లోగల CURRUPT OFFICERS పై సమర్పించిన ప్రాతినిధ్యం పై మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Periodical Register, Distribution Register, Note File with Rule Position తో పాటు ఇవ్వగలరు.
3. మీ విద్య కాఖ పై (Accreditation) గుర్తింపు పొందిన పత్రికలలో వచ్చిన Adverse News పై మీరు తీసుకున్న చర్యల ప్రతులు రూల్ పోసిషన్ తోపాటు 01-01-2017 నుండి నేటి వరకు తెలియపరచగలరు.
4. RTI Act లోని సెక్షన్ 4 ప్రకారం మరియు DOPT జారీ చేసిన మార్గదర్శకాల SUMOTO DISCLOSURES ను మీరు ఏమి ప్రజలకు తెలియపరిచినారో వాటి రుజువులను electronic మరియు manual mode లో ప్రభుత్వ ఆదేశాల ప్రకారం ఇవ్వగలరు.
5. RTI Act కి సంబంధించిన REGISTER 1 & 2 ను ఇవ్వగలరు. అప్పీసుకి వచ్చిన 6 (1) APPLICATIONS & 19 (1) APPEAL ORDERS లను 2 (J) ప్రకారం 01-01-2017 నుండి నేటి వరకు ఇవ్వగలరు.
6. మీ office కు వచ్చిన మరియు పంపిన E- mails ప్రతులు, వచ్చిన మరియు ఇచ్చిన MEMOS, ప్రతులు, circulars, order, AUDIT PARAS, Disiplinary proceedings లను 1-11- 2017 నుండి నేటి వరకు ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 26-05-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri K. Srinivas Rao, Assistant Secretary to Government, School Education Department, Telangana Secretariat, Hyderabad is present and filed his affidavit stating that vide letter No: 2749/Ser.II/A1/2020-2 dated: 27-07-2020 the application was transferred u/s 6(3) of the RTI Act 2005 to the PIO / O/o the Commissioner & Director of School Education, Hyderabad with a request to pursue the matter. The PIO filed the copy of the letter along with the postal receipts before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO / O/o the Commissioner & Director of School Education, Hyderabad to furnish the information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
