## **Order**

Dr. P. Surendranath Reddy, Hyderabad has filed 2<sup>nd</sup> appeal dated: Nil which was received by this Commission on 18-01-2019 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-08-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) The daily progress made on my complaints dated 13-07-2018
- 2) Reasons for delay in taking action on my complaints.
- 3) Names and designations of officials who have considered my complaints and the number of days it was lying with each official during this period.
- 4) Please provide copies of file noting indicating the consideration of my complaints from the date of receipt till date by the concerned officials. I would also like to inspect all documents relating to my case.
- 5) A copy of the rules/ regulations/ orders/ citizens charter which lay down the timeline for disposal of matters.
- 6) Names and designations of officials who are responsible for dereliction of duty for delaying my complaints in violation of relevant rules/ regulations/ orders.
- 7) Date by when action would be completed in my case?

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 07-09-2018 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The Commission notice dated: 10-08-2021 sent to the appellant was returned to the Commission by the Postal Department with an endorsement that "No such person". Sri G. Naresh, advocate on behalf of Sri A. Kranthi Kumar Reddy, Standing Counsel for High Court, O/o the Registrar Judicial, High Court of Judicature at Hyderabad, State of Telangana, Hyderabad is present and filed the affidavit stating that the information was furnished to the appellant vide letter Roc. No: 576/PIO/JUDL/2018 dated: 23-08-2018 and filed a copy of the same before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 01-08-2018 seeking information on 7 points and the PIO has furnished the complete information to the appellant.

Since the sought information is furnished, the appeal is closed.
