## Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed a Complaint dated 27-07-2020 which was received by this Commission on 07-08-2020 for not getting the information sought by him from the PIO / O/o the Regional Joint Director, School Education Department, Warangal District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Ms. M. Vanitha, Assistant Director, O/o the Regional Joint Director, School Education, Warangal District is present and filed her affidavit stating that the information for point No: 3 & 4 was given to the complainant vide letter Rc. No: 863/B4/RTI/2020 dated: 25-06-2020 and filed copies of the same before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 27-08-2020 seeking information on 6 points and the PIO has furnished the information for point No: 3 & 4.

The Commission directs the PIO to give a specific reply and furnish the remaining information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
