## Order

Sri. Mohd Ashraf, Sirpur Kagaznagar, Kumarambheem Asifabad District has filed 2<sup>nd</sup> appeal dated: 27-07-2020 which was received by this Commission on 07-08-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Sirpur-Kagaznagar, Kumarambheem Asifabad District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Kagaznagar Division, Kumarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- కాగిత సగర్ మండలం లోని గ్రామం బోరిగా, బోడిపల్లె శివారులోని ల్యాండ్ పునర్నిర్మాణ శివారులోని ల్యాండ్ సర్వే కోసం చెప్పిన దరకాస్తుల వివరాలు. సర్వే రిపోర్ట్ లను 01-04-2017 నుండి నేటి వరకు ఇవ్వగలరు
- కాగిత సగర్ మండలం లోని గ్రామం బోరిగా, శివారులో సర్వే నం 191/4 పై చెప్పిన పిల్లారుల వివరాలు మరియు సర్వే రిపోర్ట్ లను ఇవ్వగలరు మరియు ముఖ్యంగా RTI Act 1977 ప్రకారం దరకల ప్రతులు ఇవ్వగలరు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 06-06-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 30-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 30-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Vishnu, Deputy Tahsildar, Sirpur Kagaznagar Mandal, Komaram Bheem Asifabad District responded and requested to give time to furnish the information.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 08-05-2020 seeking information on 2 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Sri Vishnu Jadav, Deputy Tahsildar, Sirpur Kagaznagar Mandal, Komaram Bheem Asifabad District responded for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
