Order

Sri Mohd Ashraf, Sirpur-Kagaznagar, Kumarambheem Asifabad District has filed a Complaint dated 25-07-2020 which was received by this Commission on 07-08-2020 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Kumarambheem Asifabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 08-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 08-07-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has not furnished the information. The PIO / Sri. Gammienal, Assistant Director, O/o the DEO, Komaram Bheem Asifabad District responded and requested to give time to furnish the information to the complainant.

Heard both the parties and perused the material paper available on record and observed that the complainant filed his 6(1) application dated: 27-05-2020 seeking information on 4 points.

The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Sri. Gammenial, Assistant Director, O/o the District Educational Officer, Komaram Bheem Asifabad District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the complete information to the complainant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
