Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed a Complaint dated 27-07-2020 which was received by this Commission on 07-08-2020 for not getting the information sought by him from the PIO / O/o the District Collector, Asifabad, Komarambheem Asifabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 02-03-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1 నేటి వరకు మీ పరిధిలో ఆడ, వట్టివారు, ప్రాణహిత చేపల్ల జగన్నాద్ పూర్ ప్రాజెక్ట్ నిర్మాణానికి భూసేకరణ కోసం రెవిన్యూ ఆధికారులు పత్రికలకు విడుదల చేసిన భూసేకరణ ప్రకటన పత్రాలు (పత్రికల పేర్లతో సహా) మరియు (బి) గజట్ నోటిఫికేషన్లు సర్టిఫైడ్ కాపీలను పంపగలరు.
- 2 నేటి వరకు మీ పరిధిలో ఆడ, వట్టివారు, ప్రాణహిత చేపల్ల జగన్నాద్ పూర్ ప్రాజెక్ట్ నిర్మాణానికి భూసేకరణ కింద పునరావాసం, ఉపాది, హితుబద్ధమైన పరిహారం చెల్లించాల్సిన ఫండ్లింగ్ రైతుల జాబితా (రైతుల పేర్లు, చిరునామాలు, గ్రామం పేర్లు, మండలం పేర్లు, పరిహారం విలువ, ఇతరత్రా) పంపగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is present and stated that the PIO has not furnished the information. The APIO / Sri Rafatulla Hussain, Administrative Officer is present and filed the affidavit of the PIO / Sri K. Suresh, District Revenue Officer, O/o the District Collector, Komaram Bheem Asifabad District stating that vide letter No: A2/336/2020 dated: 10-03-2020 and 30-08-2021 the application was transferred u/s 6(3) of the RTI Act 2005 to the PIO / O/o the Revenue Divisional Officer, Asifabad Division, Komaram Bheem Asifabad District with a request to furnish the information to the complainant. The APIO filed a copy of the letters before the Commission.

Heard both the parties and perused the material papers available on record. The Commission took a serious view and directs to issue **Show Cause Notice** to the present & the then PIO / O/o the Revenue Divisional Officer, Asifabad Division, Komaram Bheem Asifabad District for not furnishing the information to the complainant within the stipulated period even after transferring the application twice u/s 6(3) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO / O/o the Revenue Divisional Officer, Komaram Bheem Asifabad District to give a specific reply and furnish the information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
