## **Order**

Smt. P. Sharada, Bodhan has filed 2<sup>nd</sup> appeal dated: 13-08-2020 which was received by this Commission on 19-08-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Bodhan Mandal, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 2) తేది. 01-01-2019 నుండి 31-12-2019 వరకు రెవిన్యూ భూమి వివాదములు వివిధ కోర్టులలో పెండింగ్లో ఉన్నప్పుడు మ్యూటేషన్ చేసిన భూముల మ్యూటేషన్ ఆర్డర్లు మొత్తం ప్రతులు జిరాక్స్ చేసి ప్రతిపేజీ ధృవీకరించి ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 22-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 05-08-2021 at 10.30 A.M.

The case is called on 05-08-2021. The appellant is absent. The PIO / Sri E. Sailu, Deputy Tahsildar, Bodhan Mandal, Nizamabad District is present and stated that the information was furnished to the appellant vide letter No: E/666/2020 dated: 21-08-2020 and filed the acknowledgement of the appellant before the Commission.

The PIO / Sri MK. Muntajibuddin, Divisional Administrative Officer, Bodhan Division, Nizambad District is present and stated that vide letter No: B2/794/2020 dated: 21-08-2020 a notice was issued for hearing on 21-08-2020 to the appellant and the PIO with a direction to furnish the information to the appellant.

Heard the PIO and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 17-06-2020 seeking information on 2 points and the PIO has furnished the information to the appellant.

The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information once again to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
