## Order

Sri S. Dharmendra Singh, Adilabad District has filed 2<sup>nd</sup> appeal dated: 27-08-2020 which was received by this Commission on 01-09-2020 for not getting the information sought by him from the PIO / O/o the Director, SCERTS, Opposite L.B. Stadium, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Director, SCERTS, Opposite L.B. Stadium, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Name of the Applicant: S.DHARMENDRA SINGH
2. Full address: H.No. 6-7-103/5, Bhuktapur, Adilabad (Cell No.9494433139)
3. Particulars of Information required:
  - i. Copy of list of "Aims and Objectives of webinars" conducted by SCERTS, Hyderabad
  - ii. Criteria for arranging sequence of webinars in the time table
  - iii. List of webinars telecasted till now on behalf of SCERTS, Hyderabad in the following format
  - iv. List of experts who approved the webinars before telecasting with their qualifications
  - v. No. of views and watch time on YouTube channel of each webinar telecasted

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 07-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 05-08-2021 at 10.30 A.M.

The case is called on 05-08-2021. The appellant is absent. The PIO / Sri A. Narender, Lecturer is present and filed affidavit of Smt. M. Radha Reddy, Director, State Council of Educational Research and Training, Hyderabad stating that the information was furnished to the appellant vide letter No: 04/Estt./RTI/TSCERT/2020 dated: 19-09-2020 and the same was dispatched through RPAD on 21-09-2020. The PIO filed the copies of the information furnished before the Commission.

Heard the PIO and perused the material paper available on record and observed that the PIO has not furnished the information for point No: 3 (v) as sought through 6(1) application dated: 03-06-2020.

The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information relating to point No: 3 (v) to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
