Order

Sri. G. Chandramulli, Karimnagar District has filed 2nd appeal dated: 20-01-2020 which was received by this Commission on 21-01-2020 for not getting the information sought by him from the PIO / O/o the Mandal Praja Parishad, Kothapalli Mandal, Karimnagar District and 1st Appellate Authority / O/o the Mandal Praja Parishad, Kothapalli Mandal, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-11-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

నప్పటినుండి ఎప్పటి వరకు ఇమి చౌసన్ ఆధారాలు క్రింద
ఇవ్వండి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 27-11-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 15-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 15-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has furnished wrong information. The PIO / Sri. D. Srinivas, Mandal Panchayat Officer, MPP Kothapalli Mandal, Karimnagar District responded and submitted that vide letter No: D/RTI/37/27/11/2019 dated: 06-12-2019 the application was transferred u/s 6(3) of RTI Act to the PIO / Panchayat Secretary, Gram Panchayat Elagandal Kothapalli Mandal, Karimnagar District and the said information was furnished to the appellant vide letter No: E/RTI/06/2019 dated: 20-12-2019. The PIO filed a copy of the information furnished along with the postal receipts before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 01-11-2019 seeking information on Two (2) points and the PIO has not furnished the information for point No: 1 and has not attested the copies of the information furnished.

The Commission directs the PIO / Panchayat Secretary, Gram Panchayat Elagandal Kothapalli Mandal, Karimnagar District to give point wise specific reply duly attesting all the copies to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
