## Order

Sri Muneppa, Hyderabad has filed a Complaint dated 29-08-2020 which was received by this Commission on 04-09-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Amerchinta Village & Mandal, Wanaparthy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

(2) నా ప్రయోగం తెలుసుకుని రికార్డు సూచించి సర్టిఫైడ్ లెటర్లు జారీచేయమని గురి కారణాలను తెలియజేయమని కోరుకుంటున్నాను.  
(3) రికార్డు సూచించి సర్టిఫైడ్ లెటర్లు జారీచేయమని కోరుకుంటున్నాను. దీనిలో భాగం నెంబర్ 306, ఆ గురించి సర్టిఫైడ్ లెటర్లు జారీచేయమని కోరుకుంటున్నాను.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is absent. The PIO / Smt. K. Anuradha, Deputy Tahsildar, Amerchinta Village, Wanaparthy District is present and stated that the complete information was furnished to the complainant vide letter No: B/RTI/626/2020 dated: 28-07-2020 by hand under acknowledgement of the complainant. The PIO filed a copy of the information furnished to the complainant before the Commission.

Heard the PIO and perused the material paper available on record.

The Commission directs the PIO to furnish the information duly attesting the same to the complainant once again within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complainant is closed.
