## Order

Sri Beemari Raju, Kamareddy District has filed 2<sup>nd</sup> appeal dated: 14-09-2020 which was received by this Commission on 22-09-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Domakonda Mandal, Kamareddy District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Kamareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 02-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 17-08-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 27-08-2021 at 10.30 A.M.

The case is called on 27-08-2021. The appellant is absent. The PIO / Sri P. Narendra Reddy, Mandal Revenue Inspector, O/o the Tahsildar, Domakonda Mandal, Kamareddy District is present and filed his affidavit stating that point wise information was furnished to the appellant by hand vide letter No: B/489/2020 dated: 30-07-2020 and filed a copy of the same before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 02-07-2020 seeking information on 4 points and the PIO has furnished the information on 30-07-2020. The appellant through his 2<sup>nd</sup> appeal dated: 14-09-2020 stated that the PIO has furnished incomplete and wrong information, but failed to submit as to what information furnished is incomplete or wrong information.

The Commission directs the PIO to arrange for verification of records on a mutually fixed date and time by giving prior intimation to the appellant and furnish the required information as sought through his 6(1) application dated: 02-07-2020 to the appellant and to report compliance to the Commission.

With the above direction, the appeal is closed.
