Order

Sri. Ramoji Veerachary, Adilabad District has filed 2nd appeal dated: 16-09-2020 which was received by this Commission on 22-09-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Soan Mandal, Nirmal District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Please furnish the report regarding on which date form No.X received in Tahasil office the Returning officer i.e., Tahasildar has not put the initial on the form No.X claim, this should be furnished to me on which date the form No.X claim received from Sri Shaik Moinuddin S/o. Shaik Abdulla.
- 2) As per G.O.Ms. No.1765 Revenue (SS-1) Department dt. 15-10-2005 have issued orders the land on sada sale deed to get their transaction valid and also recommended that the sale transaction behind present cut off date 31-07-1989 may be amended upto 31-12-2000 and the date of receipt of application may be amended to make it 31-12-2005 the alignee are transfer shall file an application in form No.X on before 31-12-2005 again the Government have amended for extension of period for filing of X claims upto 31-03-2008 vide G.O.ms. No.77 Revenue (SS1) Dept., dt. 25-01-2008, Xerox copy of two G.Os. are sent herewith. On which date the form No.X claim received by the then Tahasildar may be furnished to me. Whether it is received before 31-12-2005 or 31-03-2008 or earlier which date received please furnish the information in writing to me.

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 05-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is present and stated that the PIO has furnished incomplete information. The PIO / Sri J. Rohidas, Deputy Tahsildar and Smt. G. Laxmi, Divisional Administrative Officer, Soan Mandal, Nirmal District are present and filed their affidavit stating that the available information was furnished to the appellant by hand vide letter No: C/169/2018 dated: 14-09-2020 and filed the copies of the information furnished to the appellant along with the acknowledgement of the appellant before the Commission.

Heard both the parties and perused the material paper available on record and observed that the appellant through his 6(1) application dated: 28-08-2020 seeking information on 6 points. The appellant stated that the PIO has not furnished the copy of 13A, 13B, 13C, Challan and ROR Proceedings. The PIO submitted that the information sought is not available.

The Commission directs the PIO to give a specific reply to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
