## **Order**

Sri Parul Sharma, Haryana has filed 2<sup>nd</sup> appeal dated: 09-05-2018 which was received by this Commission on 14-05-2018 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State Telangana, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Registrar General, High Court for the State Telangana, Hyderabad

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 15-11-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Subject matter of information -

I had filed a Complaint on 30.06.2017 with regard to OS No. 434 of 2014 of XXV ACJ, City Civil Court, Hyderabad wherein Mr. Prashant Kumar appeared to have filed a notarized will and upon inspection by Investigating Agency from EOW, New Delhi, the report states that the will is un notarised and my complaint is in respect substitution of the un notarised WILL deed document in place of Notarized WILL Deed dated 15.01.2009- Action- Requested-Regarding.

Specify the particulars of information required:

The applicant is the authorised representative of M/s Vipul Ltd. and had filed a complaint on 30.06.2017. The applicant want to know the present status of the complaint, under Section 6 of RTI Act, 2005, wishes to get the following information:-

- (i) Please specify who is the competent authority to take appropriate action on the complaint filed by the applicant.
- (ii) Please provide the present status of the complaint. Whether any action/ enquiry has been taken or not? If yes, please provide the copy(s) thereof.
- (iii) Please specify what steps were/has been taken by the Ld. Registrar (V) of the Hon'ble High Court of Judicature for the State of Telangana & A. P., Hyderabad.
- (iv) Please specify if the tempering of court record in respect of the OS no. 434 of 2014 was/has been found?
- (v) Please specify if answer to (iv) above is affirmative, what steps have been taken by the Competent Authority.? Please provide the copy of action taken by the competent Authority.

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 04-01-2018 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The appellant is absent. Sri J. Anil Kumar, Standing Counsel and advocate on record for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and submitted that point wise reply was given to the appellant vide letter ROC No: 888/PIO/JUDL/2017 dated: 01-12-2017.

Heard the PIO and perused the material papers available on record and observed that the appellant through 6(1) application dated: 15-11-2017 is seeking information on 6 points and the PIO vide letter dated: 01-12-2017 furnished point wise reply for point No: 1 to 5 and for point No: 6 the PIO informed the appellant that it is confidential in nature and has not furnished the same. The First Appellate Authority through his order in appeal No: 05 of 2018 dated: 06-02-2018 in appeal No: 5 of 2018 directed the PIO to allow the appeal partly within 7 days from the date of receiving the order. The PIO has not submitted any documentary evidence whether the said information for point No: 6 was furnished to the appellant as per the direction of the First Appellate Authority or not.

The Commission directs the PIO to furnish the information for point No: 6 as directed by the First Appellate Authority order dated: 06-02-2018 to the appellant within One (1) week from the date of receipt of this order through Registered post acknowledgement due and to report compliance to the Commission.

With the above direction, the appeals are closed.
