

Order

Sri Sabir Ahmed Khan, Mancherial District has filed 2nd appeal dated: 12-05-2018 which was received by this Commission on 15-05-2018 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 09-02-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:



A. Number of writ petitions are -
Pending after receiving its counter
affidavits & its reply counter -
affidavits in service matters - by
year wise.

B. In which procedure the above
Pending writ petitions are listing
daily in High Court gazette either
year wise or 81 no. wise or 2 -
discreted by the Hon'ble judges in
mention petitions.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 13-03-2018 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The appellant is absent. Sri Swaroop Oorilla, Standing Counsel and advocate on record for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and submitted that a reply was given to the appellant vide letter ROC No: 455/PIO/JUDL/2018 dated: 17-07-2018 and on filing the 1st appeal dated: 13-03-2018 the First Appellate Authority vide order in appeal No: 146 of 2018 dated: 17-09-2018 passed an order finding no merit on the impugned order of the SPIO.

Heard the PIO and perused the material papers available on record. The Commission is of the view that there is no fault in the order of the SPIO or of the First Appellate Authority.

In view of the above the appeal is closed.
