Order

Sri Rayeeca M. A Khadir, Hyderabad has filed 2nd appeal dated: 30-09-2020 which was received by this Commission on 01-10-2020 for not getting the information sought by him from the PIO / O/o the Director of Government Examinations, Government of Telangana, Chapel Road, Hyderabad and 1st Appellate Authority / O/o the Director of Government Examinations, Government of Telangana, Chapel Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Enclosed is the specific request dated 08-06-2020 to carry out necessary corrections in the Proceedings No: Rc No: 126/D / 19-3/2020 dated 11-03-2020 with regards to writing of correct name of Father of the Candidate namely " M A Qayyum ".

Since then, it is about fortnight and it appears no action had been taken on it, in view of which it is requested to provide action taken report with regards to necessary corrections in the Proceedings Rc No: 126/D / 19-3/2020 dated 11-03-2020 as requested in the enclosed letter dated 08-06-2020.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 10-07-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The appellant was present and filed his affidavit stating that the PIO has furnished the information. The PIO / Sri K. Srinivasa Rao, Deputy Commissioner, O/o the Director of Government Examinations, Hyderabad is present and submitted that the information was furnished to the appellant vide letter Rc. No: 158/Nlg-3/2020 dated: 30-06-2020 and filed a copy of the same along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 17-06-2020 seeking the action taken on his request dated: 08-06-2020 and the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
