Order

Sri M. Prajarajam, Nizamabad District has filed a Complaint dated: 24-09-2020 which was received by this Commission on 01-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Navipet Mandal, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 17-03-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

'2005 ప్రకారము ఇవ్వగలరని కోరుచున్నాను.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is present and stated that the PIO has not furnished the information. The APIO / Sri B. Devi Singh, Senior Assistant is present and filed affidavit of the PIO / Sri B. Raja Shekhar, Deputy Tahsildar, Navipet Mandal, Nizamabad District stating that the information was furnished to the complainant vide letter No: A/151/2020 dated: 20-03-2020 and again on receipt of the Commission notice dated: 09-08-2021 the information was once again furnished to the complainant. The PIO filed a copy of the information furnished to the complainant before the Commission.

Heard both the parties and perused the material paper available on record.

Since the information is furnished, the complaint is closed.
