Order

Sri Mohd. Rafatullah, Hyderabad has filed 2nd appeal dated: 29-09-2020 which was received by this Commission on 05-10-2020 for not getting the information sought by him from the PIO / O/o the TREI-Recruitment Board, Chacha Nehru Park, Masabtank, Hyderabad and 1st Appellate Authority / O/o the TREI-Recruitment Board, Chacha Nehru Park, Masabtank, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 04-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I submit that Certificate Verification for the post of Junior Lecturer (Urdu) was done on the 23-5-19 A.N and demonstration was conducted on 25-6-2019

In this connection I request you, sir, to kindly provide me a copy of the followings:-

- 1) Kindly provide me a copy of Certificate & Marks Memo of a) Graduation, b) Post Graduation and c) Professional Qualification of the candidates bearing Hall ticket Nos:301201143 and 301201185 for Junior Lecturer (Urdu) post and also kindly specify whether they passed B.Ed or Urdu Pandit training**
- 2) Copy of Certificate Verification Report of the Official Members who have verified the certificates of the above two candidates.**
- 3) A copy of list of candidates appointed to the post of J.L (Urdu) in Zone VI (Notification No:3/2018).**

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 11-08-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri U. Lava Kumar, Superintendent and Sri Linga Reddy, Assistant Secretary, (OSD-Legal), O/o the TREI-Recruitment Board, Hyderabad are present and filed their affidavits stating that replies were given to the appellant vide letter No: 12/RTI ACT/TREI-RB/2018 dated: 04-07-2020 and vide letter dated: 06-07-2020 and were sent through RPAD and the same were returned by the postal Department with a noting that "address insufficient" and the same letters were given by hand to the appellant. The PIO filed the copies of the replies along with the postal receipts before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 04-06-2020 seeking information on 3 points and the PIO vide letter dated: 06-07-2020 informed that the information sought cannot be furnished as per Section 8(1) (j) of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant (keeping in view of Section 8, 9, 10 & 11 of RTI Act 2005) within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
