## Order

Sri T. Bhumaiyah, Bodhan has filed 2<sup>nd</sup> appeal dated: 26-09-2020 which was received by this Commission on 05-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Bodhan Municipal Corporation, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Municipal Commissioner, Bodhan Municipal Corporation, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 14-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

ఈ ముఖ్య సమాచారం వివరాలు కోర్కె ఫైనల్ చేయబడినవి

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 25-08-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 23-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 23-07-2021 with prior intimation to the concerned parties. The appellant did not respond. The PIO / Sri. Narayandas, Manager, O/o the Municipal Commissioner, Bodhan Municipal Corporation, Nizambad District responded and stated that the information was furnished to the appellant vide letter No: G1/190/RTI/2020 dated: 13-08-2020 and filed a copy of the information furnished to the appellant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 14-07-2020 seeking certain information and the PIO submitted that the information was furnished on 13-08-2020 and as per the postal receipt it shows that it was dispatched on 20-07-2021 which is contrary and misleading. The Commission cannot accept the submission made by the PIO.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / O/o the Municipal Commissioner, Bodhan Municipal Corporation, Nizambad District. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the complete information to the appellant once again within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
