## **Order**

Sri. Sultan Bamahdi, Nizamabad District has filed 2<sup>nd</sup> appeal dated: 01-10-2020 which was received by this Commission on 07-10-2020 for not getting the information sought by him from the PIO / O/o the District Revenue Officer, Nizamabad Collectorate, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Joint Collector, Nizamabad Collectorate, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Copy of the complete Current File & DRO Nizamabad Note File No. B3/1856/2016 whereby that Ac 3-20Gts of land in Sy. No. 253/1 of Arsapally Shivar has been allotted for Muslim Graveyard.
- 2) Copy of the allotment proceedings.
- 3) Copy of the ground map of that land which has been allotted for Muslim Graveyard.
- 4) Copy of the DRO Nzb Proc. No. B3/1856/2016 Dt. 08/07/2018.
- 5) Information about action taken to communicate the allotment of land to the T.S. Waqf Board.
- 6) Information about action taken to handover the physical of that land to the T.S. Waqf board.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 03-08-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is absent. Sri B. Chandra Shekhar, Additional Collector, Nizambad Collectorate, Nizambad District is present and filed affidavit stating that as per the directions of the Commission in appeal No: 7511/SIC-SK/2020 dated: 16-04-2021 the available information was furnished to the appellant vide letter No: E2/1250/2021 dated: 22-07-2021 and the remaining information would be available with the PIO / O/o the Revenue Divisional Officer, Nizambad Mandal & District. The PIO filed the copies of the information furnished to the appellant before the Commission.

Heard the PIO and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 26-06-2020 seeking information on 6 points.

The Commission directs the PIO / O/o the District Collector, Nizambad Collectorate, Nizambad District & the PIO / O/o the Revenue Divisional Officer, Nizambad Mandal & District to give a specific reply and furnish the information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
