## **Order**

Sri. Md. Shaukat Ali, Sangareddy District has filed 2<sup>nd</sup> appeal dated: 05-10-2020 which was received by this Commission on 07-10-2020 for not getting the information sought by him from the PIO / the Panchayat Secretary, Malgi Village, Nayalkal Mandal, Sangareddy District and 1<sup>st</sup> Appellate Authority / O/o the Panchayat Secretary, Malgi Village, Nayalkal Mandal, Sangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Please provide the details of the uses development works of general funds in malgi village nayalkal mandel sangareddy district with the parches of bills copy and mode of payments Xerox copy since 01-01-2018 to till the date of reply this RTI Act 2005 application.
- 2) Please provide the details of the received the tax details in malgi village with receipts of villagers' and any company in village malgi mandel nayalkal district sangareddy from 01-01-2018 to till the date of reply this RTI Act 2005 Application.
- 3) Please provide the details of the sanction copy of GP aprovel teermanam copy of GP malgi village nayalkal mandel district sangareddy from 01-01-2018 to till the date of reply this RTI ACT 2005 Application.
- 4) After recived of the above information I want to present verify in receipt All the files & records U/S 2(j) (i) & give the date and time for verify the Record in office time.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 18-09-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri D. Kishan Reddy, Panchayat Secretary and the First Appellate Authority / Sri Vaidya Srinivas, Mandal Panchayat Officer, Malgi Village, Nayalkal Mandal, Sanga Reddy District are present and filed their affidavits stating that the information was furnished to the appellant on 27-12-2019, but failed to submit the documentary evidence and postal evidence before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 21-07-2020 seeking information on 4 points. Upon not filing the documentary evidence, the Commission cannot accept the submissions of the PIO.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO / Sri D. Kishan Reddy, Panchayat Secretary and & the then PIO / Sri B. Yadaiah, Panchayat Secretary, Malgi Village, Nayalkal Mandal, Sanga Reddy District for not furnishing the information to the appellant. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIOs to arrange for verification of records on a mutually fixed date and time by issuing prior intimation to the appellant to enable him to obtain the required specific information and to report compliance to the Commission.

With the above direction, the appeal is closed.
