## Order

Smt. C. Sumithra, Hyderabad has filed 2<sup>nd</sup> appeal dated: 16-10-2020 which was received by this Commission on 19-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Corporation Bandlaguda Jagir, Rajendranagar Mandal, Rangareddy District and 1<sup>st</sup> Appellate Authority / O/o the Municipal Corporation Bandlaguda Jagir, Rajendranagar Mandal, Rangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 06-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. was that road mentioned laid by gram panchaya peeramcheru, which now part of municipal corporation Bandlaguda jagir.
2. Is that road mentioned currently is an asset of municipal corporation Bandlaguda jagir.
3. In which year and month the road has been laid
4. what was the expenditure incurred to laid the road by peeramcheru grampanchayat
5. Under which scheme or which funds the road has been laid by peeramcheru grampanchayat.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 24-08-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The appellant is absent. The APIO / Sri C. Madhusudhan Rao, Senior Assistant, O/o the Municipal Corporation, Bandlaguda Jagir Municipality, Rajendrangar Mandal, Rangareddy District is present and stated that a reply was given to the appellant by hand vide letter No: RTI/4584/2020-21 dated: 23-09-2020 and filed the copy of the information furnished to the appellant before the Commission.

Heard the APIO and perused the material papers available on record and observed that the PIO has furnished information to the appellant.

Since the information is furnished, the appeal is closed.
