Order

Sri D. Uday Kiran, Adilabad District has filed 2nd appeal dated: 09-10-2020 which was received by this Commission on 19-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Adilabad Municipality, Adilabad District and 1st Appellate Authority / O/o the Municipal Commissioner, Adilabad Municipality, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 30-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ① I need the information of construction permission is providing in G.S. NO of plots. to construction of Star Bld Built up. House
- ② I need information. what is the process of taking permission G.S. NO village Khanapur. G.P Ankanam mandal. Adilabad.
- ③ How many floors construction permission is there. in S. NO 68. G.P Ankanam mandal Adilabad.
- ④ Construction permission 1500 sqt Govt fee and other expenditure for permission.

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 23-08-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 12:00 P.M.

The case is called on 17-09-2021. The appellant is absent. The APIO / Sri M. Saikiran, Town Planning Section, O/o the Municipal Commissioner, Adilabad Municipality, Adilabad District is present and stated that the information was furnished to the appellant vide letter Roc. No: RTI/49(69)/2020 dated: 20-04-2020, but failed to submit the postal evidence of furnishing the information to the appellant.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 30-07-2020 seeking information on 4 points. Upon not filing the documentary evidence of furnishing the information, the Commission cannot accept the submissions of the PIO.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO / Sri. M. Saikiran, Town Planning Section & the then PIO / Sri B. Vandanam, Assistant City Planner, O/o the Municipal Commissioner, Adilabad Municipality, Adilabad District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the information to the appellant immediately through Registered post acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
