## Order

Sri. L. Rajaiah, Mancherial District has filed 2<sup>nd</sup> appeal dated: 15-10-2020 which was received by this Commission on 20-10-2020 for not getting the information sought by him from the PIO / O/o the Revenue Divisional Officer, Mancherial Mandal & District and 1<sup>st</sup> Appellate Authority / O/o the District Revenue Officer, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 09-08-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) కడప జిల్లా 2A విభజనయొక్క ప్రాంతపు లా సెంట్రల్ యూనియన్లులకు P.D.F ఫోటోలును సంబంధించిన అడ్డు 102 వారికి విస్తరించుటకు ప్రయత్నించారు. వారికి ప్రాప్తించిన ప్లాట్లకు సంబంధించి యిరియం వారి జగ్గం సుండా మీరు అడ్డు తీసుకున్న చిరాక్కు ఇవ్వాలి ప్రయోగం.
- 2) P.D.F.S మొదటి అంకం వారికి లాం మెరియం పొందే ప్రయత్నం చేసి ఎవరి అడ్డు ప్రాజెక్టుల కాలవల విజిల్లంలు తీసుంటా? ప్రస్తావించారు. ఆర్ విజిల్లం కాలవల. ప్రాజెక్టు సంబంధించి ప్రయోగం చేసి జగ్గం వంటి 102 పేజీ లిస్టును పంపించుటకు ప్రయత్నించారు. వారికి సంబంధించిన కడప జిల్లా కలెక్టరేట్ లో విస్తరించుటకు ప్రయత్నించారు. ప్రయోగం చేసి వింజమంబడి అతి తక్కువ ప్రాప్తించారు. ప్రాజెక్టు సంబంధించి ప్రయోగం.
- 3) కంప్యూటర్ ద్వారా అప్రూవల్ వాసిన చిరాక్కు ఇవ్వాలి ప్రయోగం.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 10-12-2019 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 01-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Kishan, Administrative Office, O/o the Revenue Divisional Officer, Mancherial Mandal & District responded and stated that the information was furnished to the appellant vide letter Rc. No: I/248/2021 dated: 29-06-2021 and filed a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 09-08-2019 seeking information on 3 points. Upon not getting any information from the PIO the appellant filed 1<sup>st</sup> appeal dated: 10-12-2019 and the District Revenue Officer, Mancherial District vide letter No: A2/RTI/276/2020 dated: 05-02-2020 directed the PIO and the appellant to appear for hearing on 11-02-2020. The Commission is of the view that inspite of directions given by the District Revenue Officer, Mancherial District, the PIO failed to furnish the information to the appellant, which shows that there is a gross negligence & dereliction of duties against the provisions of RTI Act 2005.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / O/o the Revenue Divisional Officer, Mancherial Mandal & District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
