Order

Sri M. Sharnappa, Ranga Reddy District has filed a Complaint dated: 20-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Rajendranagar Circle, GHMC, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 04-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

It is submitted that I am in need of information about the which registered Document produced by CH.BALAJI for obtaining Door No.8-13-55/2, and Property Tax Tin No.1110839357.

The said information in the form of Document may be issued with official seal and signature.

Therefore I request your kind authority be pleased to furnish the information as stated above

4. I hereby state that the information sought for is not covered under the categories which are exempted from disclosure of information under Section 8 or under Section 9 of the Right to Information Act, 2005 to the best of my knowledge it pertains to your Secretariat.

5. I hereby state that the prescribed application fee of Rs.10/- has been paid through Court fee Stamps.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 08-07-2021 at 11.00 A.M

In view of the Covid -19 Pandemic, the cases are heard over phone on 08-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Shanawaz, Assistant Municipal Commissioner, Circle – 11, GHMC, Hyderabad responded and stated that a reply was given to the appellant vide letter No: 22/A1/RJNRC/GHMC/2019-20 dated: 11-09-2020 stating that as per Section 11 of RTI Act a notice was issued to the 3rd party for taking the consent whether to furnish the information to the appellant or not, since the 3rd party did not respond no information was furnished to the appellant.

Heard both the parties and perused the material paper available on record.

The Commission directs the PIO to furnish the information to the appellant (Keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) within Ten (10) days from the date of receipt of this order through Registered post acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
