Order

Sri. H. Anantha Padmanabha, Hyderabad has filed 2nd appeal dated: 20-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mahabubnagar Urban, Mahabubnagar District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Mahabubnagar Division, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 10-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

అనుమతిని RTI Act - 2005 కింద ఇవ్వగలరు.
- (2) మరల నిర్జీతము 1 లోని రిజి (2) డి.నెం: 4881/
2016, డి: 5/2/2016 పై పాత్రము జిల్లా కలెక్టర్
అనుమతిని RTI Act - 2005 కింద ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 14-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 23-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 23-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Raja Gopal, Deputy Tahsildar, Mahabubnagar Urban Mandal, Mahabubnagar District responded and stated that the information was furnished to the appellant vide letter No: I/1677/2021 dated: 19-07-2021 and filed a copy of the information furnished along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 10-08-2020 seeking certain information.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Deputy Tahsildar, Mahabubnagar Urban Mandal, Mahabubnagar District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

Since the information is furnished, the appeal is closed.
