Order

Sri. Mohd Ashraf, Sirpur-Kagaznagar, Kumarambheem Asifabad District has filed a Complaint dated 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Sirpur-T Mandal, Kumarambheem Asifabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. దొని రాజయ్య తండ్రి నాని, హీరాపూర్ గ్రామం, మండలం సెయ్యూర్ (టి) గారు మీ కార్యాలయంలో 08-05-2020, 03-06-2020 & 07-07-2020 తేదీలలో వీరి ల్యాండ్ సమస్య పై ఫిర్యాదు చేసినారు. వీరు సమర్పించిన ప్రాతినిధ్యం పై మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Periodical Register, Distribution Register, Note File with Rule Position తో పాటు ఇవ్వగలరు. ఏ Rule Position ప్రకారం ఇప్పటి వరకు పరిష్కరించ లేదు ప్రస్తుత స్థితి తో పాటు Rule Position ను తెలుపగలరు. (Copy Enclosed).
2. మీ కార్యాలయంలో total అని ల్యాండ్ సమస్యలు పెండింగ్ లో ఉన్నాయి? వచ్చిన సమస్యల పై మీరు మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Periodical Register, Distribution Register, Note File with Rule Position తో పాటు ఇవ్వగలరు. ఏ Rule Position ప్రకారం ఇప్పటి వరకు పరిష్కరించ లేదు ప్రస్తుత స్థితి తో పాటు Rule Position ను తెలుపగలరు. (Copy Enclosed).
3. మీ కార్యాలయనికి సంబంధించిన ల్యాండ్ సమస్యల పై ఉన్నత అధికారుల నుండి వచ్చిన orders వాటి ఆధారంగా మీరు మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Periodical Register, Distribution Register, Note File with Rule Position తో పాటు ఇవ్వగలరు. ఏ Rule Position ప్రకారం ఇప్పటి వరకు పరిష్కరించ లేదు ప్రస్తుత స్థితి తో పాటు Rule Position ను తెలుపగలరు. (Copy Enclosed)

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 01-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The Complainant responded and stated that the PIO has not furnished the information. The PIO / Sri. Vaman Rao, Deputy Tahsildar, Sirpur – T Mandal, Komaram Bheem Asifabad District responded and stated that the information was furnished to the Complainant on 30-06-2021, but failed to submit any documentary evidence of furnishing the information to the Complainant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the filed 6(1) application dated: 24-08-2020 seeking information on 3 points. Upon not filing any documentary evidence of furnishing the information, the Commission cannot accept the submission of the PIO

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Deputy Tahsildar, Sirpur – T Mandal, Komaram Bheem Asifabad District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the complete information to the complainant within One (1) week from the date of receipt of this order through Registered post acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
