Order

Sri Mohd Ashraf, Sirpur-Kagaznagar, Kumarambheem Asifabad District has filed a Complaint dated 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Komarambheem Asifabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

2. ఇప్పటి వరకు నేను మీ కార్యాలయంలో ఇచ్చిన complaints ఎన్ని? సంబంధిత complaints ప్రకారం తీసుకొన్న శాఖాపరమైన చర్యల ప్రతుల ఋజువులు ఇవ్వగలరు. CCA Rules ప్రకారం ఏ చర్య తీసుకోవాలి . మీరు చర్యలు తీసుకోకపోవడానికి గల కారణాలను తెలియపరచగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 15-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 15-07-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has not furnished the information. The PIO / Sri Gammennal, Assistant Director, O/o the District Educational Officer, Komaram Bheem Asifabad District responded and requested to give time to furnish the information.

Heard both the parties and perused the material paper available on record and observed that the complainant through his 6(1) application dated: 27-07-2020 is seeking information on 2 points and the PIO has failed to furnish the information.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Sri Gammienal, Assistant Director, O/o the District Educational Officer, Komaram Bheem Asifabad District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to arrange for verification of records on a mutually convenient date and time by giving prior intimation to the complainant to enable him to inspect the records and furnish the required information duly keeping in view the Sections 8, 9, 10 & 11 of RTI Act 2005 within One (1) Week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
