Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed a Complaint dated: 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) Funds received from the Government / Election Commission / Head of Department sanction order and deposited details, Head wise, Voucher Wise detailed statement of Election Expenditure incurred from Govt. Funds received for the purpose of Elections.
- 2) Election Expenditure Account Cash Book Xerox copy, Election Account Bank Statement.
- 3) Expenditure Incurred from Municipal General Funds or Any Other Account of Municipality for the purpose of Elections. Cash Books Xerox copy from 2018-2019, 2019-2020 and 2020-2021.
- 4) What are the Stationery Items / Election materials / other material items purchased bills and its Stock register Xerox copies.
- 5) What are the facilities provided and materials items purchased for, accommodation, convenience etc for Election Observers during the Municipal election process- item wise details.
- 6) Stock registers copies of the material items purchased for Election Observers.
- 7) After completion of Elections, where are the purchased material items available and in whose custody the material items are available now. Material items Handed Over and Taken over Stock Register copies.
- 8) What is the process method followed / adopted for purchase of Stationery items/different materials items purchased for conduct of election purpose.
- 9) Work orders issued to different Trades/Suppliers for purchase items / various kinds of services - Xerox copies required.

And more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 16-09-2021 at 12:00 P.M.

The case is called on 16-09-2021. The complainant is absent. The PIO / Sri B. Ganga Bhushan, Junior Assistant, O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District is present and filed his affidavit stating that the information was furnished to the complainant vide letter No: RTI/998/2020 dated: 10-09-2020 and filed the copy of the information furnished to the complainant before the Commission.

Heard the PIO and perused the material papers available on record and observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.

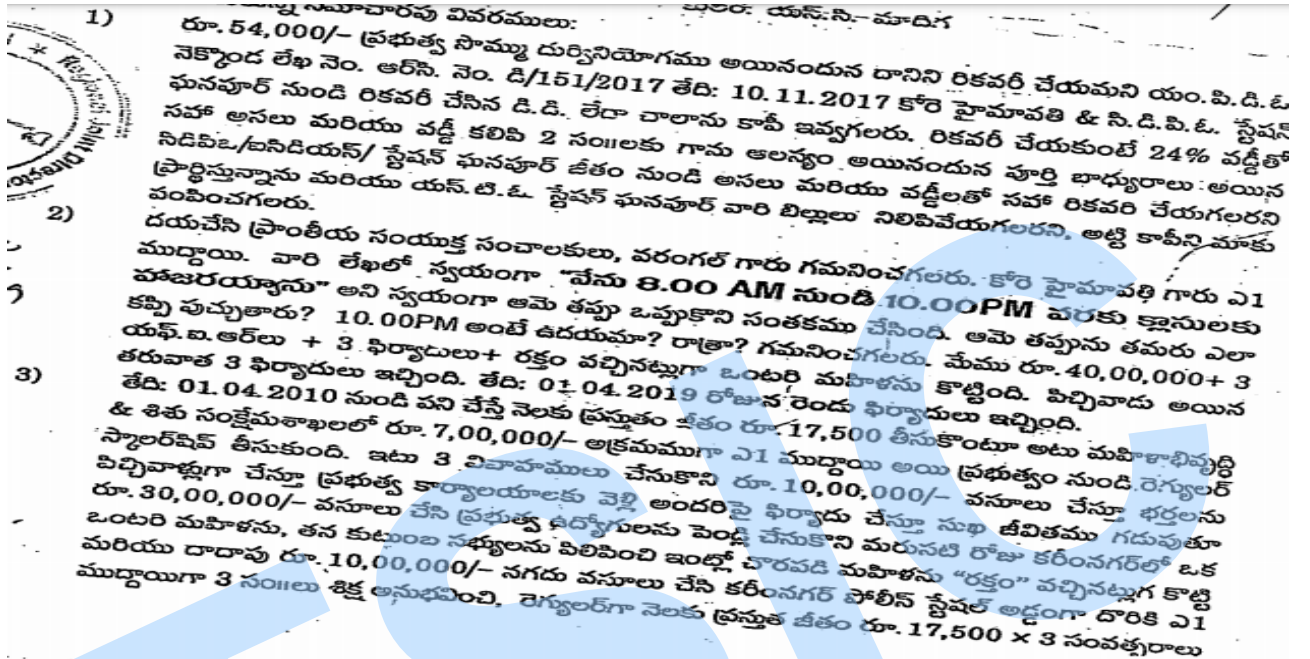
