## **Order**

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed a Complaint dated 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Principal Secretary to School Education, Secretariat, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 13-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) Certain serious corruption news article published in Adab Hyderabad Newspapers regarding School Education which involved the entire School Education Administration System. What action is taken in the matter? Whether enquiry is conducted in the matter, provide a copy of the enquiry reports. If the enquiry is not conducted what is the reasons for not conducting enquiry.
- 2) Provide detailed Record Sheet of all the employees/staff in all cadres/grades in the prescribed form, working in Office of the Director School Education Hyderabad and Regional Director Warangal and Hyderabad Region Offices containing Name, date of birth, first original appointment date, first appointment designation and appointment place, promotion date, promotion post name, on promotion place of posting if subsequent promotions are given to the candidate details of the subsequent promotions cadres/grades date and place etc., along with detailed period of the concerned employee worked/working in a particular section and subjects dealt and dealing by each and every employee in all cadres from June 2014 to till date.
- 3) Since how many years the Staff working in Director Office is in long standing, why they are not transferred Shifted to Other Offices/places reasons thereof. Provide service rules pertaining to Director School Education Administration Hyderabad, Regional Director Warangal and Hyderabad Offices employees of all cadres/grades.
- 4) Provide a detailed statement of the Transfers and Postings of the District Education Officers / ADS in all grades/cadres/categories in Hyderabad and Warangal Regions from June 2014 to till date.
- 5) Provide a detailed statement of the Transfers and Postings of the Employees working in Director Office and Other Offices Employees working under the control of Director School Education Hyderabad in all cadres categories from Jan 2010 to till date excluding Districts Education offices.
- 6) How many Sanctioned Posts of District Education Officers / ADS in all Grades/Cadres in all the District Education Offices of Hyderabad & Warangal Region/Zones, Nos. of post existing as on June 2014 and Nos. of posts Sanctioned till date details required and their sanction order copies.

The PIO / O/o the Principal Secretary to School Education, Secretariat, Hyderabad vide Lr. No. 3737/SE.GEN.II/2020 dated. 18-08-2020 transferred the application U/s 6(3) of the RTI Act to O/o the Commissioner and Director of School Education, Hyderabad with a request to furnish the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Sri G. Paramesham, Assistant Director, O/o the Commissioner & Director of School Education, Hyderabad is present and filed his affidavit stating that a reply was given to the complainant vide letter No: 88/Ser.I/2020 dated: 22-09-2020 and filed a copy of the information furnished to the complainant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 13-08-2020 seeking information on 20 points. The Commission is of the view that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
