Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed a Complaint dated 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Provide the land encroachment complaints regarding government land, plots and court cases from 2014 to till date which are in your custody. Provide the action take report on news paper clipping regarding land encroachments and tour dairy / work done statement of TPO, TPS & TPBO from 2014 to till date
2. Office Attendance Register page where the name of TPO, TPS & TPBO is signed day wise at Municipality from the date of Joining to till date, month wise. And their Casual Leaves applications copies applied and utilized by them year wise, month wise with dates from the date of Joining to till date
3. How Many days (OD) on Duty attended Head Offices/Meetings/Trainings/ Deputation etc., month wise / years wise / date wise detailed particulars statement of TPO, TPS & TPBO and provide the On Duty (OD), attended the Head Offices/Meetings/Trainings/ etc., instructions copies / order copies and Attendance Certificates of from the date of Joining to till date
4. Annual Property Returns statement Xerox copy of TPO, TPS & TPBO. As per Employees conduct rules 1953 and Lokayukta and Lok pal rules.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is present and stated that the PIO has not furnished the information. The APIO / Sri M. Prakash, Senior Assistant, O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District is present and filed affidavit stating that the 6(1) application dated: 27-08-2020 is not received by their office and on receipt of the Commission notice dated: 09-08-2021 the information is brought to the Commission and is ready to be furnished to the complainant.

Perused the material papers available on record and observed that the complainant filed 6(1) application dated: 27-08-2020 seeking information on 4 points and the postal receipt enclosed goes to show as 14-08-2020 which is prior before filing the 6(1) application.

Keeping in view of the above, the Commission directs the PIO to furnish the available information to the appellant immediately on the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
