Order

Sri M. Kiran, Nizamabad District has filed a Complaint dated 16-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nizamabad Municipal Corporation, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 18-09-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

7. ప్రతి సమాచారము తెలుగులో రిఫర్మం పర్మిషన్లు మరియు ప్లాన్లు మరియు ప్రతి సమాచారము, ప్రతి వివరములు క్లుప్తంగా వివరించబడు.

(A) ఈ కార్యక్రమాల పరిధిలో క్లుప్త పరిచయ, గ్రీన్ ప్లాన్లు, నిర్మాణ నియమాలు, నిర్మాణ, అభివృద్ధి మరియు వివరములు (సర్టిఫికేట్లు, ఫోటోగ్రాఫ్లు, G.I. layout copies, G.I. layout Permission copy, NUDA Permission copy, NUDA Permission copy, అభివృద్ధి మరియు వివరములు) తెలుగులో.

(B) క్లుప్తంగా ఈ కార్యక్రమాల పరిధిలో నిర్మాణాలను, క్లుప్త పరిచయ, నిర్మాణ నియమాలు, అభివృద్ధి మరియు వివరములు (సర్టిఫికేట్లు, ఫోటోగ్రాఫ్లు, నిర్మాణ నియమాలు మరియు వివరములు) తెలుగులో పరిచయం చేయబడుతుంది మరియు అభివృద్ధి మరియు వివరములు తెలుగులో పరిచయం చేయబడుతుంది.

The Public Information Officer vide Lr. No. G1/PIO/6141/2020 dated. 29-09-2020 furnished the information to the Complainant.

Stating that the PIO furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 23-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 23-07-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has not furnished the information. The PIO / Sri Karunakar, Town Planning Officer, O/o the Municipal Commissioner, Nizamabad Municipality, Nizamabad District responded and stated that a reply was given to the complainant vide letter No: G1/PIO/6141/2020 dated: 29-09-2020.

Heard both the parties and perused the material papers available on record and observed that the complainant through his 6(1) application dated: 18-09-2020 seeking information on 3 points and the PIO responded that the information sought is in general nature and is not as per Section 2(f) of the RTI Act 2005. The Commission is of the view that the PIO ought to have furnished the available information to the appellant.

The Commission directs the PIO to allow the complainant for verification of records on a mutually fixed date and time by issuing prior intimation to the complainant to enable him to obtain specific information (keeping in view of Section 8, 9, 10 & 11 of RTI Act 2005) and to report compliance to the Commission.

With the above direction, the complaint is closed.
