Order

Sri Mohd Iftekharuddin, Hyderabad has filed 2nd appeal dated: 21-10-2020 which was received by this Commission on 22-10-2020 for not getting the information sought by him from the PIO / O/o the Deputy Municipal Commissioner, Circle-7, South Zone, GHMC, Sardarmahal, Charminar, Hyderabad and 1st Appellate Authority / O/o the Zonal Commissioner, South Zone, GHMC, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 16-05-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Kind attention invited to the subject and reference cited , it is appreciated you have furnished the information under RTI , the building permit and sanction plan copy in file No. 52648/28.11.2015/CO4 Permit No. 47134/DC/SZ/Cir-4/2015 as per said sanction plan the permission was granted on plot No. 2,3 and 4 to the extent of area 279.38 Esquire yard or 233.56 Esquire meter as per allotment of plots to the tribal community by the Housing Board authorities there are 4 Numbers of plots i.e. plot No, 1,2,3,4, to the extent of are 78 to 95 esquire yards each area a copy is enclosed for your perusal .

Kindly clarify the :

1. Plot Number 2,3,4, owners name.
2. The area of each plot.
3. Whether the permission granted in proposed road, is there any provision in the GHMC act for Granting of permission on road.
4. The concerned Section Officer and ACP visited the area and observed the construction and any action taken please inform.
5. Fix up the boundaries of permission allotted plot.
6. Please furnish the sale deed copy of plot number 2,3,4,.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 15-02-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The appellant is present and stated that the PIO has not furnished information. The PIO / O/o the Deputy Commissioner, Circle No7, South Zone, Sardar Mahal, GHMC, Hyderabad is absent.

Heard the appellant and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 16-05-2019 seeking information on 6 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO and the then PIO / O/o the Deputy Commissioner, Circle No7, South Zone, Sardar Mahal, GHMC, Hyderabad for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI Act and for not appearing before the Commission for the hearing held on 26-08-2021. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the complete information to the appellant (keeping in view of Section 8, 9, 10 & 11 of RTI Act 2005) within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
